To the ordinary shareholders of Videndum plc

Dear Shareholder,

We attach a notice from Deloitte, given under section 519 of the Companies Act 2006, which we are required to circulate to shareholders.

As noted in the attached, and as previously reported to shareholders, Deloitte informed the Company during 2022 that from 2024 it would no longer be able to act as auditor to Videndum Plc (the "Company").

Accordingly, in the first half of 2023 the Company conducted a competitive tender process for the position of statutory auditor which was fully described in the 2023 Annual Report. Deloitte elected not to participate in the tender, the outcome of which was to recommend that shareholders approve the appointment of PwC as the Company's new auditor at the upcoming 2024 AGM.

Deloitte has referenced in their notice certain matters that are already detailed in the 2023 Annual Report (at page 151). The Board has acknowledged these matters as part of the 2023 year-end audit process and has put measures in place, or is in the process of doing so, to address them fully.

The Board reiterates its recommendation to vote in favour of all resolutions, including the appointment of PwC as auditor, at the 2024 AGM.

Statement of reasons relating to Deloitte LLP ceasing to act as auditor of Videndum plc

We are not seeking reappointment as auditor of the company and, accordingly, will cease to hold office at the conclusion of the Annual General Meeting held on 19 June 2024. During 2022 we informed the Audit Committee that from 2024 we will no longer be able to act as auditor for the Company. The Company undertook a competitive tender process for the position of statutory auditor and we elected not to participate.

Circumstances which we believe should be brought to the attention of members and creditors, which are consistent with those set out in our audit report to the 31 December 2023 Annual Report and Accounts, primarily related to observations related to:

- o the precision of controls related to the inventory provision calculations;
- o preparation of the going concern and acquired intangible impairment models and the precision of the management review controls of these models;
- o precision of review controls around monthly reconciliations and comparisons of actuals to budget;
- o completeness of controls over accounting for marketing related costs and any changes in customer terms; and,
- o the level of management challenge relating to the classification of adjusting items.

Unless you apply to the Court, this statement must be sent by you within 14 days to every person entitled under Section 423 of the Companies Act 2006 to be sent copies of the company's accounts. This is a requirement of Section 520(2) of that Act. Unless you inform us that you have applied to the court, we are required to file a copy of this statement at Companies House.
